**RHODDIR DRWY HYN RYBUDD** fod Cyngor Sir Ynys Môn/Isle of Anglesey County Council yn bwriadu dim llai na saith niwrnod ar ôl dyddiad y rhybudd hwn wneud Gormchymyn bydd yn gwahardd dros dro pob cerbyd, ac eithrio cerbydau argyfwng, rhag teithio mewn unrhyw gyfeiriad ar hyd Lôn Myfyrian, Gaerwen.

Mae angen y Gormchymyn er mwyn galluogi gwaith cynnal a chadw ac ail wynebu'r briffordd.

Y ffordd arall yw o bwynt y caead ger y bont rheilffordd, teithio mewn cyfeiriad de gorllewinol pasio Fferm Bodowyr Isaf, y Railway Cottages a Fferm Treferwydd nes cyrraedd prif ffordd B4419. Troi i'r dde yn y gyffordd a chario 'mlaen ar hyd y B4419 tuag at Pentre Berw/Gaerwen ac ar ôl teithio am tua 1 ¼ milltir cymryd y troad cyntaf ar yr ochr dde i fynd ar Lôn Ynys Ferw. Teithio ar hyd y ffordd ddi-ddosbarth hon mewn cyfeiriad de dwyreiniol am tua 1 ½ milltir pasio Ynys-Ferw ac Myfyrian-Uchaf (Meculo) nes cyrraedd y gyffordd ar ochr arall y caead. Bydd y gwrthwyneb yn berthnasol i draffig sy'n teithio i'r cyfeiriad arall.

Daw'r Gormchymyn i rym ar 4<sup>th</sup> Ebrill, 2022 a bydd yn parhau mewn grym am gyfnod na fydd yn fwy na 4 wythnos neu hyd nes y cwblheir y gwaith y bwriedir ei wneud ar y ffordd, pa un bynnag fyddo gyntaf. Ar hyn o bryd disgwylir i'r gwaith gael ei gwblhau ar 15fed Ebrill, 2022.

**NOTICE IS HEREBY GIVEN** that Cyngor Sir Ynys Môn/Isle of Anglesey County Council intend not less than seven days from the date hereof to make an Order, the effect of which will temporarily prohibit all vehicles, except for emergency vehicles, from travelling in either direction along Lôn Myfyrian, Gaerwen.

The Order is necessary for highway maintenance and resurfacing works.

The alternative route will be from the point of closure near the railway bridge, travel in a south westerly direction past Bodowyr Isaf Farm, the Railway Cottages and Treferwydd Farm until you finally reach the B4419 main road. Turn right at the junction and proceed along the B4419 towards Pentre Berw/Gaerwen and after travelling for approximately 1 ¼ miles take the first turning on the right hand side onto Lôn Ynys Ferw. Travel along this unclassified road in a south easterly direction for approximately 1 ½ miles past Ynys-Ferw and Myfyrian-Uchaf (Meculo) until you arrive at the junction on the other side of the road closure. Vice versa to the above instructions for traffic travelling in the opposite direction.

The Order comes into effect on 4<sup>th</sup> April, 2022 and will continue in force for a period not exceeding 4 weeks or until the work which it is proposed to carry out on the road is completed, whichever is the earlier. At this stage it is anticipated that the works will be completed on 15<sup>th</sup> April 2022.
