
Mae angen y Gorchymyn er mwyn galluogi gwaith ail-wynebu a lledaenu'r llwybr.

NOTICE IS HEREBY GIVEN that Cyngor Sir Ynys Môn/Isle of Anglesey County Council intend not less than seven days from the date hereof to make an Order, the effect of which will temporarily prohibit traffic on foot, on bicycle or any other means of traffic from travelling in either direction on a section of the Lôn Las Cefni cycle path.

The section of the Lôn Las Cefni cycle path to be closed is from the roundabout by Farm & Pet Place, Llangefni (SH4608774623) the path proceeds generally South alongside Afon Cefni for 1.7KM to the A5 (SH4618273053). There is no alternative route.

The Order is necessary to enable path resurfacing and widening works.

The Order comes into effect on 21st April 2022 and will continue in force for a period not exceeding 2 months or until the work which it is proposed to carry out on the road is completed, whichever is the earlier.
